Location

The tournament will be held at the Northwest Texas Field & Stream range, located at 4472 Old Friberg Road #B, Wichita Falls, TX 76305. To reach the range, exit I-44 East on FM 171 in the direction (east) of the Municipal Airport. Continue past the airport and make the first left turn at Emmert Road, followed by a right turn onto Old Friberg Road.

Classification

The CMP Competitor Classification system (detailed in Section 3.11.4) will be used for all matches. Classification and TSRA membership cards will be checked at time of registration. Unclassified competitors will compete in the Master Class unless there are three (3) or more unclassified competitors. In this case a special unclassified class will be provided, and awards given. Shooters may elect to compete in one of the following divisions:

-Metallic Class (iron sights) -Open Class -.22 Only Class

<u>Rule</u>

Current CMP pistol rules will govern in their respective matches: Triggers may be checked at any time during the match. A set of approved trigger weights will be available for competitors to check firearms prior to the match. Triggers will be weighed for the CMP Service Pistol, .22 and Service Revolver matches. Match winners and apparent leg point winners will have their triggers weighed following the match.

Eligibility for Texas Precision Pistol Championship

All competitors must be members of the TSRA. Non-Members who are not a resident of Texas must become a match member for a fee of \$10.00. A match member is a member of TSRA for the duration of the match. All Texas competitors are required to be members in good standing of the TSRA.

Eligibility for EIC Matches

Open to all eligible participants. You need not be a member of the CMP affiliated club to participate. Course of Fire: National Match Course of Fire (See section 5.2.2, Table 5)

Eligibility for the CMP Service Revolver Match: Open to all eligible participants. You need not be a member of the CMP affiliated club to participate. 40 Shot Presidents Pistol Match Course of Fire. (See section 5.2.1, Table 4)

Junior Shooter Eligibility

As defined by CMP Section 2.6.3, Junior (U21) are civilians under the age of 21 on the first day of the competition. Juniors under the age of 18 must have a handgun authorization form signed by their parent or guardian. A form is included with this program, at the end. For young shooters with limited competitive experience please contact Josh Wyatt or Odie Hitt to determine their eligibility to compete in this State Match.

<u>Awards</u>

Awards will be made for the Match winner and first in class. No competitor will be eligible for more than one award in class.

-First place will be awarded for 3-6 competitors in a class

-Second place will be awarded for 7-11 competitors in a class

-Third place will be awarded for over 12 competitors in a class

An award will be made to the:

High Grand Senior, High Senior, High Junior, High Woman, and High Veteran

If there are less than 3 competitors in the high Master class, high master shooters will shoot for the win only.

Entries Limited

Entries limited to 68; competitors are urged to send in entries early to ensure a spot on the line. Entry fees can be paid at check in. Completed entry forms received by close of business April 15, 2024 will be entered into a drawing for \$100.

<u>Post Entries</u>

Excepted to range limitation, will close at 7:30 A.M. on May 3, 2024. Competitors will not be turned away as long as range space is available.

Pre-Registration Requested

Pre-registration by mail or email is requested. Registration will reserve your place on the firing line. All registrations received will be acknowledged if an email address is provided. You may pre-pay or pay when you sign in. Entry form is located at the end of this bulletin.

NOTE: If a competitor pays a package fee but withdraws from competition after having fired any portion of the match, no refund will be given (emergencies excepted). Entry fees will be accepted at the match until the match is full.

<u>Required Equipment</u>

ECIs for guns, EYE and HEARING PROTECTION are required for shooters and spectators at all times while on the firing line.

Match Conditions

Stat office will issue score cards. Scoring will be done down range. Scorers and competitors will sign and turn in the score cards at the end of each match fired. Range personnel will assist in all ways possible to avoid unnecessary delays.

<u>Entry Fees</u>

A TSRA Team Support fee is included in the registration fee. Fees do not include TSRA membership dues, (required if not a current member).
